Substitutes with DP/FLEX – Things to Remember

DP

- Must be batting
- May be on defense along with the FLEX

FLEX

- Must be playing defense
- If they go into bat, it must be for the DP

Group Discussions

- Create different topics for each group
- Separate umpires into groups give each group a different topic to complete
- Give the groups 10-15 minutes to complete the questions
- Have each group report out their findings to the larger group
 - If possible project their questions on screen as they read and give their answers
- Assign a different group to ask questions first then open it to the room



Example of questions handed out to group

Group 1-Interference

1. This must occur for an offensive player to be guilty of interference

2. This is the proper mechanic when a runner interferes with a defensive player

3. When the ball has passed a fielder (other than the pitcher) for there to be interference another fielder has to be able to _____?

4. These types of interference would result in the runner closest to home being called out.(3 total answers)

5. This type of interference is a delayed dead ball.



Example of slide to discuss answers

1. This must occur for an offensive player to be guilty of interference hinder, impede or confuse the defensive player

2. This is the proper mechanic when a runner interferes with a defensive player dead ball, the runner is out, all other runners must return to the last base touched at the time of the interference

3. When the ball has passed a fielder (other than the pitcher) for there to be interference another fielder has to be able to _____?
get an out

4. These types of interference would result in the runner closest to home being called out.(3 total answers) interference by a retired runner, interference by an on deck batter, or interference by an offensive player other than a runner

5. This type of interference is a delayed dead ball. interference by the plate umpire

Diagramming Plays


• Two approaches

- 1. Pick an umpire to come up to board and give the play having them draw umpire movements and placement.
- 2. Handout plays to groups give them time to collaborate and determine their responses. Have each group then present their play to the group.

Presentation methods

- Screen projected on white board
- Use white board
- Use an easel pad
