2019 and 2020 Women's National Team (WNT) Training Camp in Iwakuni, Japan

Chris Sebren provided the BOD with a report on a request from the City of Iwakuni, Japan to host the WNT in 2019 and 2020 to train for the Japan Cup and Olympic Games, respectively. Iwakuni has previous experience hosting as the 2018 WNT held a training camp there prior to the WBSC Women's World Championship.
